4a (Code:) (Expenses \$ 1,781,270. including grants of \$ 1,658,275.) (Revenue \$ 64,818.) Mother Hubbard's Cupboard is an all-volunteer organization and has no paid staff. We utilized dedicated community volunteers to distribute approximately 920,000 pounds of food in 2023 for 67,151 individuals, a 39% increase over the number of clients served in 2022, and a 93% increase over the number of clients served in 2021. In 2023, 30% of our clients were children and 24% were seniors. Specially tailored food options were provided to meet the needs of diabetic clients and clients who were unhoused or had no access to cooking or refrigeration appliances. Clients were permitted to come for service up to three times monthly and each time received adequate food for three to five days of meals assuming three meals per day for every household member. Unhoused clients or those lacking appliances could come for

Anyone from the public can call and set up an appointment with a board member to view Mother Hubbard's Cupboard's form 990, governing documents, conflict of interest policy and financial statements.
